Description of the programme

A training program aimed at qualifying Sharia and law graduates in the skills of Plead before the judiciary and providing legal advice in family and marital issues, so that After graduating from the program, the legal consultant is committed to providing legal services Consultative Voluntary for divorced women and their equivalents.

Through the legal incubator program, the association was able to qualify 300 female consultants. Legal skills on pleading and providing consultations He was able to provide approximately 36,000 hours of legal work in personal status cases. Volunteering for the benefit of the association, and to distinguish the outcomes of the program The Incubator The Ministry of Justice sought the help of graduates of the program to provide legal consultations Janiya for personal status court reviews In Riyadh, by opening a Mawaddah office for human rights support in the court as the first A women's book of its kind that represents the first participation of women Saudi Arabia in the judiciary in a professional, organized manner, and with the success achieved by the Mawaddah Office At the Riyadh Court; The Ministry of Justice issued directives Personal status courts in major cities to enable Mawaddah to open similar offices To provide free legal support services to women Reviews, and Mawaddah was able to open a similar office in the Personal Status Court. What is the legal incubator program?

The legal incubator is a three-month training program consisting of (192) training hours. It includes a group of specialized training units in various legal fields financial, legal, social and other fields related processes, which are subject to a number of controls and scientific standards to ensure the safety of the process being performed Training according to the highest quality standards, so that Women enrolled in this program receive legitimate and legal qualifications according to the law developments in the judicial field, they also obtain the necessary skill and experience to enable them to practice their profession and plead before the judiciary Providing legal and legal advice

In personal status cases

The trainee provides Legal consultations for the benefit of the association and the groups benefiting from its services under the supervision of He started managing the association's legal affairs, and The association provides this consultation to divorced women who are in a similar situation as they are married.





The justifications that led to the legal incubator?

- The noticeable increase in divorce rates in Saudi society and the exacerbation of domestic problems This is a result of the low level of human rights awareness. Society in general and women in particular
- The increasing number of family cases in courts, and the need to provide judicial aid A free grant for women in need, which enhances the concept Volunteer human rights work
- Loss of the rights of many divorced women, their equals, and their children as a result of low awareness Their legal status, and the need to raise their awareness and provide the necessary legal support to enable them to enjoy those rights.
- Women are discouraged from the general atmosphere of the courts
- Because women in particular suffer from great difficulties in the issues of divorce, suspension, and abandonment Needs some privacy Between women and women in areas where it is difficult for the client to disclose the facts to the male lawyer, which results in the loss of many Women are denied their rights for reasons that embarrass them from visiting the law firms where they work. It affects men, and their inability to stand up for themselves Before the judiciary, especially those who do not have a legal guardian, such as divorced and divorced women.
- This program is consistent with the directives of the Ministry of Justice in supporting female lawyers and licensing them and their uncles. To provide a legal status that guarantees women Their legal and regulatory rights
- The need to expand the areas of charitable and volunteer work and transition its programs from pastoralism towards development
- Growing number of female graduates from colleges of Sharia and Law
- There is no legal or legal impediment that prevents a woman from pleading on behalf of others before the judiciary or providing legal consultations

The justifications that led to the legal incubator?

- The program achieved its goal of establishing a judicial aid fund to provide free legal and legal advice for divorced women and the like, through the training of female cadres Specialized in the field of legal work, where he graduated 300 graduates and 10 courses until 2020 AD. It provides free legal aid Intention for the beneficiaries of the association's services of the requirements and requirements
- Achieving the program's goal of contributing to raising judicial efficiency in the judiciary Marital and family matters, by forming an orientation A female jurist in the judicial field working to provide judicial aid free of charge in accordance with the legal and regulatory requirements, which It represents obtaining the confidence of the general court through a court mandate to collect Receiving a number of custody and annexation lawsuits The scheduled visit to the court is for the purpose of the association studying it and submitting a report Among the recommendations establishing the judicial ruling
- The Ministry of Justice seeks assistance from female graduates of the legal incubator to provide free legal advice. Intent for Personal Status Court reviews In other major cities, the Ministry enabled the association to open offices Wedda for legal support in civil status courts Personality in each of: "Riyadh, Makkah Al-Mukarramah, Medina, Jeddah, Dammam" and is currently underway. Expand and open in other cities, so that These offices include qualified legal consultants to provide legal services Instant for court reviews





- The issuance of a royal order requiring the conclusion of a memorandum of understanding with the Mawaddah Association to benefit from the benefits I raised her in the "legal incubator" program to provide Legal aid for cases of domestic violence
- Approval from the Ministry of Social Affairs to establish the program as an annual strategic program for Association
- The program was approved by the General Organization for Technical and Vocational Training.
